Increase State revenues by \$2,182 and appropriate \$2,182 into Veterans State Matching Funds account.

BACKGROUND

The State of North Carolina Department of Military and Veterans Affairs has made a distribution of grant funds to those North Carolina counties which: (1) Fund and operate a County Veterans Services Office, and (2) Submitted a timely application for a portion of the available funds. Gaston County applied for a portion of the grant funds and provided the necessary documentation to the NCDMVA, the application was granted, and on or about February 10, 2020, \$2,182 was directly deposited into Gaston County's account.
