



RESOLUTION TITLE: A RESOLUTION BY THE COUNTY OF GASTON TO DIRECT THE EXPENDITURE OF OPIOID SETTLEMENT FUNDS

WHEREAS, Gaston County has joined national settlement agreements with companies engaged in the manufacturing, distribution, and dispensing of opioids; and,

WHEREAS, the allocation, use, and reporting of funds stemming from these national settlement agreements and bankruptcy resolutions ("Opioid Settlement Funds") are governed by the Memorandum of Agreement Between the State of North Carolina and Local Governments on Proceeds Relating to the Settlement of Opioid Litigation ("MOA"), the Supplemental Agreement for Additional Funds from Additional Settlements of Opioid Litigation ("SAAF"), and SAAF-2; and,

WHEREAS, Gaston County has received Opioid Settlement Funds pursuant to these national settlement agreements and deposited the Opioid Settlement Funds in a separate special revenue fund as required by section D of the MOA; and,

WHEREAS, section E.6 of the MOA states that, before spending opioid settlement funds, the local government's governing body must adopt a resolution that:

- (i) indicates that it is an authorization for expenditure of opioid settlement funds; and,
- (ii) states the specific strategy or strategies the county or municipality intends to fund pursuant to Option A or Option B, using the item letter and/or number in Exhibit A or Exhibit B to identify each funded strategy; and,
- (iii) states the amount dedicated to each strategy for a specific period of time.

NOW, THEREFORE, BE IT RESOLVED, in alignment with the NC MOA, SAAF, and SAAF-2, Gaston County authorizes the expenditure of opioid settlement funds as follows:

1. First strategy authorized
 - a. Name of strategy: Evidence-Based Addiction Treatment
 - b. Strategy is included in Exhibit A of the NC MOA
 - c. Item letter and/or number in Exhibit A or Exhibit B to the MOA: Exhibit A, Strategy 2
 - d. Amount authorized for this strategy: ~~\$668,378.00~~ \$906,324.84
 - e. Period of time during which expenditure may take place:
 - Start date July 1st, 2025 through End date June 30, 2027

- f. Description of the program, project, or activity: Gaston County Medication Assisted Treatment (MAT) Scholarship fund (GCMATS)

The GCMATS program will be developed and implemented by McLeod Centers for Wellbeing and will provide Gaston County's uninsured/underinsured residents the opportunity to receive Evidence-Based Medication Assisted Treatment for Opioid Use Disorder along with care navigation to address social determinants of health that may impact a patient's recovery, the most important among these being financial insecurity.

- g. Provider: McLeod Centers for Wellbeing

The total dollar amount of Opioid Settlement Funds appropriated across the above named and authorized strategies is ~~\$668,378.00~~ \$906,324.84.
