Appropriate Federal revenues. No additional County funds.

BUDGET ORDINANCE IMPACT

Increase Federal revenues by \$11,522 and appropriate \$11,522 into Special Programs account.

BACKGROUND

Gaston County Workforce Development has been awarded \$11,522 to assist current community college students and alleviate a financial barrier that would otherwise prohibit their completion of their course of study. This Finish Line Grant funding targets actively enrolled students who have completed at least 50% of their program requirements and is designed to increase graduation or credential attainment within seven semesters. Funds are limited to \$1,000 per student per semester. 100% Federal funds. No County match required.


