#### BUDGET IMPACT

Transfer \$10,590 from the General Fund to the General Government Capital Fund, via the Community Investment Fund. No Additional County Funds.

#### BACKGROUND

Hope United Survivor Network-Family Justice Center was approved by the North Carolina Council for Women & Youth Involvement for the purchase of the Cortexflo Photographic Examination System. The difference of \$10,590 needed for the purchase was in a non-capital account and needed to be transferred to a capital account for the purchase. Due to time restraints, the additional \$10,590 was transferred from an existing capital account and needs to be transferred back for reimbursement.

Approval of this Board Action and BCR authorizes the transfer of \$10,590 budgeted in the General Fund, NC CFWYI SA Furniture & Equipment account, to the General Government Capital Fund to reimburse for the purchase of the Cortexflo Photographic Examination System.
