BUDGET ORDINANCE IMPACT

Increase revenues by \$21,411 and appropriate \$21,411 into Special Programs accounts.

BACKGROUND

Gaston County citizens and organizations often make donations to various programs within the Department of Health and Human Services - Social Services Division. During the Third Quarter of FY 2015-2016, donations totaled \$21,411 for the Shelter and Adult Services/Nutrition program. The Shelter of Gaston County received \$19,790 in donations to be used for rent deposits, utility deposits, prescribed medications, household items and other purchases to meet client and Shelter needs. Donations to Adult Services totaling \$1,621 will be used throughout Adult Services (as specified by the donors) to enrich various program activities for the elderly. Third Quarter donations require appropriation before they can used for the purposes intended.
