



RESOLUTION TITLE: RESOLUTION IN SUPPORT OF ASSIGNING THE SERVICE SALES TAX REVENUE TO ECONOMIC DEVELOPMENT CAPITAL NEEDS

WHEREAS, the Gaston County Board of Commissioners has worked for many years to support economic development with an emphasis on tax base development, employer diversification, and job creation; and,

WHEREAS, infrastructure is a critical component of any local economic development program and the County's shovel-ready industrial parks have vastly contributed to the County's economic growth over the years; and,

WHEREAS, the current business parks are reaching capacity levels and the Gaston County Board of Commissioners has reviewed this critical need and finds that the expansion of its current business park inventory is critical to remaining competitive on a State and national level; and,

WHEREAS, the Gaston County Board of Commissioners finds it necessary to establish a funding stream for economic development capital in order to continue the advancement of economic growth and to prepare Gaston County for the next generation of job recruitment; and,


