BACKGROUND

The Sheriff's Office was awarded \$140,000.00 to continue the Domestic Violence Unit, which includes salary and partial benefits for two Domestic Violence Deputies. The DV Deputies coordinate all Sheriff's Office DV Unit activities: evictions, arrests on warrants, removing children/weapons from unsafe homes, hand delivering 50B copies to schools/day cares, mental commitments, etc.
