BACKGROUND

This project will address the urgent need of assisting domestic violence victims in making a successful transition from emergency housing into permanent housing and will provide evaluations and trauma-focused individual/group therapy to adults and children who are victims of domestic violence and/or sexual assault. Supportive services will identify and provide support to victims of DV both in the community and within the DV shelter so that recovery can occur. The grant will also cover the costs of clinical therapists to work with this population. Statistics documented by the Gaston County Sheriff's Office, The Shelter of Gaston County, Court Advocates, and Phoenix Counseling, indicate that over 2000 victims of domestic violence seek help and safety through community resources in Gaston County every year.

JUSTIFICATION FOR REQUEST:											

This project will enable a collaborative effort among community partners to implement a transitional housing program along with supportive services to address the urgent need of assisting victims of domestic violence who have left an abusive relationship to achieve financial stability and independence. Currently, there is no transitional housing program available to serve these victims. Supportive services will identify and provide support to victims of DV both in the community and within the women's shelter so that recovery can occur. The grant will also cover the costs of a contracted clinical therapist to work with this population. (No county funds)
