NOTICE OF PUBLIC HEARING

PURSUANT TO NORTH CAROLINA
GENERAL STATUTE 158-7.1

Gaston County proposes to conduct engineering tests on land located in the Dallas Township to determine its potential for an economic development project pursuant to North Carolina General Statute 158-7.1. The County Board of Commissioners intends, subject to comment at the public hearing for which notice is hereby given, to approve an appropriation of \$165,000.00, to review the following:

- Perform Phase I Environmental Audit
- Perform Topographical Survey
- Perform Soil Borings

The Board of Commissioners believes this project would stimulate and stabilize the local economy, promote business, and result in the creation of a substantial number of jobs in the County that pay at or above the median average wage in the County in the event that the property is suitable for development.

The Gaston County Board of Commissioners shall hold a public hearing on the proposed appropriation for the engineering review of this tract **at 6:00 o'clock p.m.** in The Harley B. Gaston, Jr. Public Forum - Gaston County Courthouse, 325 Dr. Martin Luther King, Jr. Way, Gastonia, N.C., **on Tuesday, August 23, 2016**, at which time any person may be heard regarding the proposed appropriation described herein. The Commissioners invite all interested persons to attend and present their views.

Following the public hearing the Board of Commissioners intends to consider the request to approve the appropriation.
