4. The Chief of the Gaston County Police Department is directed to award Detective Shaw with the service side arm and badge as specified and worn by him during his service to Gaston County, in accordance with the North Carolina General Statutes and the policy of the Board.

BE IT FURTHER RESOLVED that the Gaston County Board of Commissioners expresses their sincere gratitude for the dedicated service of Detective Jim K. Shaw and wishes him the best in his retirement.
