BACKGROUND

Hope United Survivor Network received donations during the period of October 1, 2023 to December 31, 2023 in the amount of \$103,231.81 and appropriate the following from this total: \$406.60 for Hope United Survivor Network, \$10,103.13 for The Cathy Mabry Cloninger Center, \$2,100 for The Lighthouse, \$880 in donations for the Kara's Closet initiative, \$52,705 in donations for HUSN's Hope for the Holidays initiative. \$15,037.08 in donations & \$22,000 in sponsorships for HUSN's Thread of Hope event.

The Board Action and Budget Change Request increases revenues and appropriates unrestricted funds to be used as intended by the donors.
