WHEREAS, GASTON COUNTY has received bids, pursuant to duly advertisement notice therefore, for construction of the HIGH SHOALS REGIONAL SEWER IMPROVEMENTS project; and.

WHEREAS, LKC ENGINEERING, PLLC, the County's consulting Engineer, have reviewed the bids; and.

WHEREAS, Dellinger, Inc. was the lowest bidder for the HIGH SHOALS REGIONAL SEWER IMPROVEMENTS project, with a base bid amount of \$8,022,899.50; and,

WHEREAS, the consulting Engineer recommends TENTATIVE AWARD to the lowest bidder.

NOW, THEREFORE, BE IT RESOLVED that TENTATIVE AWARD is made to the lowest bidder of Dellinger, Inc. in the Total Bid Amount of \$8,022,899.50. TENTATIVE AWARD is contingent upon the following:

- Approval of the Project Bid Information package by the NC Division of Water Infrastructure to award the contract and use SRP-W-ARP-0074 funds.
- Approval of the Construction Drawings by the City of Gastonia and the City's internal issuance of the fast-track sewer extension permit.

Upon motion of Commissioner Fraley, seconded by Commissioner Shehan, the above RESOLUTION was unanimously adopted.

Engineer's Recommendation to Award

Dear Mr. Maxwell:

Bids were received for the above-referenced project on Thursday, October 23<sup>rd</sup>, 2025. The project is intended to extend sewer into currently unsewered areas south of High Shoals near the Hardin Road interchange with US321 and generally consists of the following:

- One new duplex, submersible sewer pump station
- Approximately 16,200 linear feet of 8", 10", and 12" force mains
- Upgrades to the existing Landfill Pump Station, including new station piping and new pump impellers
- Approximately 3,200 linear feet of new 10" and 15" gravity sewer, dig-and-replace over existing gravity sewer

Five bids were accepted as summarized in the following table:

The low bidder is Dellinger, Inc. out of Monroe, NC. LKC has worked with Dellinger many times since our firm's inception and we have two active projects under construction with them at this time. They are a reputable contractor with a long history of successful projects across North Carolina, and we believe

Dellinger is capable of completing the construction in a clean and timely fashion, and we are comfortable recommending contract award to them.

Funding for some or all of this project is provided by the American Rescue Plan Act grant (Project No. SRP-W-ARP-0074).

If the County chooses to award this project, LKC recommends contract award be made to Dellinger, Inc. for their Total Bid amount of \$8,022,899.50. Any such award should be made contingent upon the following two items:

- Approval of the Project Bid Information package by the NC Division of Water Infrastructure to award the contract and use SRP-W-ARP-0074 funds.
- Approval of the Construction Drawings by the City of Gastonia and the City's internal issuance of
  the fast-track sewer extension permit. (Review is underway currently and expected to be
  approved without interrupting the project schedule.)

#### **BUDGET IMPACT**

Increase Fund Balance appropriation and expense in the Solid Waste Services Fund by \$3,475,000.

# **BACKGROUND**

In September 2022, the NC Division of Water Infrastructure awarded Gaston County \$5,478,000 in federal grant funds to meet urgent community needs in the wake of COVID-19. On September 27, 2022, Board Resolution 2022-294 approved and appropriated funds for the Dallas High Shoals Infrastructure Project (hereinafter, the "Project"). On March 28, 2023, Resolution 2023-114 appropriated an additional \$2,375,000 of gap funding from the Division of Water Infrastructure to cover a funding shortfall in the Project.

The Dallas High Shoals Regional Sewer Improvements Project (Project # SRP-W-ARP-0074) was publicly advertised, and the bids were received and officially opened on October 23, 2025. A total of six (6) bidders submitted for the project with the results listed below. Dellinger, Inc. submitted the apparent low, responsible bid in the amount of \$8,022,899.50.
