



**RESOLUTION TITLE: TO DECLARE THE ATTACHED LIST OF UNUSED EQUIPMENT AS SURPLUS AND AUTHORIZE A SURPLUS AUCTION OF THE LISTED EQUIPMENT**

WHEREAS, North Carolina General Statute §160-270(c) authorizes Gaston County to conduct public auctions of real or personal property; and,

WHEREAS, Gaston County has designated the equipment, furniture, and miscellaneous as described and listed on the attached Surplus Inventory list (Exhibit A), incorporated by reference herein, to be in poor condition, uneconomical for continued use, and having met the established surplus criteria, and,

WHEREAS, the Gaston County Board of Commissioners desires to declare said equipment surplus and to dispose of the described property as allowed by North Carolina General Statutes §160A-270 and 153A-176, subject to the limitations and procedures prescribed therein.

NOW, THEREFORE, BE IT RESOLVED by the Gaston County Board of Commissioners that:

- 1) the personal property listed on the attached Surplus Inventory List (Exhibit A), be declared surplus
- 2) the sale of the personal property listed is hereby authorized at an auctioneer
- 3) the County Manager, or designee, is authorized to enter into an agreement with an auctioneer with payment of the auctioneer to come from sales proceeds
- 4) staff is authorized to prepare the necessary documents in accordance with North Carolina General Statute 160A-266.
