## **BACKGROUND**

NCDHHS has allocated funds to each county for the Low-Income Household Water Assistance Program (LIHWAP) to begin December 1, 2021. Gaston County Gaston County was allocated \$450,306 and of this amount, \$373,124 is to be used for payments to water vendors and \$77,182 is used for administrative activities. These are 100% Federal Funds and no county funds are required. This program will assist low income families to obtain or maintain water.
