



RESOLUTION TITLE: TO AMEND GRANT PROJECT ORDINANCE 2021-264 FOR THE GASTON COUNTY CORONAVIRUS STATE AND LOCAL FISCAL RECOVERY FUNDS

WHEREAS, pursuant to Section 13.2 of Chapter 159 of the General Statutes of North Carolina, the Gaston County Grant Project Ordinance 2021-264 for the Gaston County Coronavirus State and Local Fiscal Recovery Funds was adopted in Regular Session by the Gaston County Board of Commissioners on September 28, 2021; and,

WHEREAS, the Gaston County Board of Commissioners shall amend Section 2 of the Grant Project Ordinance to authorize appropriations for specific programs, services, projects, and activities. The Board may also appropriate some or all of these funds to an enterprise fund in an annual budget ordinance for a water, wastewater, or stormwater infrastructure project.

BE IT ORDAINED by the County Commissioners of Gaston County, North Carolina, pursuant to Section 13.2 of Chapter 159 of the General Statutes of North Carolina, that:

Section 1: This ordinance is to establish a budget for a project to be funded by the Coronavirus State and Local Fiscal Recovery Funds of H.R. 1319 American Rescue Plan Act of 2021 (CSLRF). Gaston County has received the full \$43,612,126 allocation of CSLRF funds. These funds may be used for the following categories of expenditures, to the extent authorized by state law.

1. Support public health expenditures, by funding COVID-19 mitigation efforts, medical expenses, behavioral healthcare, and certain public health and safety staff
2. Address negative economic impacts caused by the public health emergency, including economic harms to workers, households, small businesses, impacted industries, and the public sector
3. Replace lost public sector revenue, using this funding to provide government services to the extent of the reduction in revenue experienced due to the pandemic
4. Provide premium pay for essential workers, offering additional support to those who have borne and will bear the greatest health risks because of their service in critical infrastructure sectors
5. Invest in water, sewer, and broadband infrastructure, making necessary investments to improve access to clean drinking water, support vital wastewater and stormwater infrastructure, and to expand access to broadband internet.



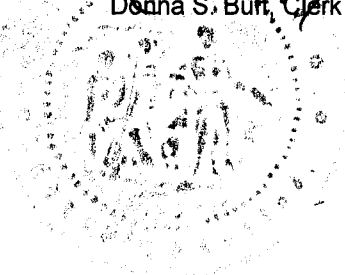

Description of Project

Gaston County Manager's Office, the Homelessness Prevention Committee, and the Gaston-Lincoln-Cleveland Continuum of Care (GLC COC) propose to use ARPA funds to support an ongoing collaborative street outreach initiative. The initiative offers a mobile one-stop-shop for unhoused and low-income populations to access social services, healthcare, housing, behavioral health, and other supportive services. It is organized by a collaborative network of nonprofit, government, and faith-based organizations who specialize in providing these services to homeless and low-income populations. There is demand to host the one-stop-shop at locations across Gaston County, especially in disadvantaged communities or isolated encampments which have difficulty in securing transportation to access services. Specifically, ARPA funds would be used to purchase (1) shower trailer and (1) laundry trailer for the mobile one-stop-shop, as well as additional program supplies such as a tent, table and chairs, portable heater, generator, and storage containers. This equipment will be used to offer immediate relief and mobile hygiene services to unhoused populations. This aligns with the best-practice health equity approach. The overall strategy of offering shower and laundry service is to: - build trust with the unhoused - improve short-term health outcomes - increase the likelihood of long-term treatment and recover

Project Plan

The County will own, transport, and service the trailers. HealthNet Gaston, the lead agency of the GLC COC, will operate the facilities while providing street outreach to users. HealthNet has an existing street outreach team that specializes in connecting unhoused populations to low- or no-cost healthcare and behavioral health. They have agreed to operate the trailers at least once a week. A detailed Memorandum of Understanding between the County and HealthNet Gaston is in progress. It will enumerate the division of responsibilities between the two lead agencies (County and HealthNet), as well as additional support duties of other agencies who are involved. For example, faith community leaders are asked to regularly stock the trailers with consumables such as shampoo, detergent, cleaning supplies, towels, and clothing. Two Rivers Utilities is asked to donate water dumping services. The County-led Homelessness Prevention Committee is also in the process of drafting a shower/laundry trailer usage policy. This policy describes how the group will handle requests for service outside of HealthNet's regularly scheduled route, and qualifications and responsibilities of any agency wishing to utilize the trailers. The policy will also include a data collection and sharing plan, so the County can keep track of program data needed for ARPA reporting.

The shower and laundry trailers will be fully ADA accessible. GS 160D-1311 enables the County to engage in and accept federal assistance for programs that are concerned with the welfare needs of persons with low and moderate income.

The primary population served by the shower and laundry trailers are defined by Treasury as assumed to be disproportionately impacted by the pandemic.

Identify a health or economic harm resulting from or exacerbated by the public health emergency, describe the nature and extent of that harm, and explain how the use of this funding would address such harm.

Statement of Need

Even before the pandemic, homelessness has been a top public health issue nationwide. The pandemic highlighted disparities in access to care and health outcomes for unhoused populations. Current best practice advocates the application of a health equity lens when designing solutions to address public health disparities among disadvantaged populations (Michener, et al.). The health equity approach prioritizes community partnerships that build trust and respond to the individualized needs of clients. It is built around the social determinants of health—meaning, issues such as housing and employment can have a dramatic impact on public health outcomes. In 2021, the Intergovernmental and Interagency Task Force on Homelessness in Gaston County wrote a report on the state of homelessness in Gaston County, which included data points demonstrating the need for services for this population. The group recommended coordinated, interagency street outreach as one solution. Attached are reports from the Continuum of care on the existing housing inventory in the County, the Point in Time Count, and the Task Force's report on homelessness in the County. Michener, et al. Population Served (Is it serving a QCT [Qualified Census Tract] or disproportionately impacted communities?)

The trailers and associated one-stop-shop are intended specifically for unhoused and low-income populations. Because it is mobile it will be deployed so it is accessible to these populations all across the County, including QCTs. The exact location of regular locations is to be determined.

Results

This initiative aims to not only offer immediate access to hygiene and healthcare, but also to connect users into the Continuum of Care's Coordinated Entry Homelessness Management Information System (HMIS). Program data will be able to be exported from this system. The ultimate goal of these street outreach efforts is to improve health outcomes and secure housing for target populations. Potential performance measures: - Number of people served - Number and type of referrals - % placed into housing

Evaluation

A data collection and data sharing agreement will be included in the shower/laundry trailer policy currently in development by the Homelessness Prevention Committee. This committee will also take the lead on program evaluation and collecting data from any program partners, such as HealthNet Gaston.

Equity Impact

This program is heavily informed by the health equity approach to service delivery. The mobile delivery model is a strategic solution to the challenges of transportation and accessibility for both urban and rural areas of the County. Mobile shower and laundry units are essential to a coordinated street outreach initiative. This equipment enables the street outreach team to bring basic hygiene and healthcare services into underserved areas, thereby reaching populations who have been disproportionately impacted by the COVID-19 pandemic. In Gaston County as well as nationwide, there are persistent disparities in both health and economic outcomes among underserved populations, including the unhoused. The initiative will support and amplify ongoing efforts to aid these populations and will improve coordination between stakeholders. All participating agencies are committed to providing services to people experiencing homelessness without discriminating based on race, color, national origin, religion, sex, gender identity, sexual orientation, disability, age, marital status, or political beliefs.

Project Partners

All partners are non-funded. An estimated breakdown of the amount of labor needed per partner is: 80% - HealthNet Gaston's street outreach team utilizes the trailers as part of their outreach efforts to homeless populations in Gaston County 15% - Gaston County transports and services the equipment 5% - Volunteers assist with staffing and keeping the program stocked with supplies

Capacity

No ARPA funds will be distributed to program partners for this project. Program partners (including HealthNet Gaston and any other agency who assists in offering the trailers as part of a street outreach event) will be required to collect and share specific program data as part of the agreement for use of the trailers. As lead agency of the Continuum of Care, HealthNet is very accustomed to reporting on federal grants. The Continuum of Care is the primary vehicle for receiving and distributing federal Housing and Urban Development grants on homelessness in the Gaston County area. They are already required to regularly collect and report on a number of demographic and programmatic variables. HealthNet's street outreach staff are accustomed to the type of work that will be needed to operate the shower and laundry trailers. GEMS staff regularly transports equipment such as the shower and laundry trailers. County staff has been involved in the planning for this project from its inception, and is prepared to take on the service and maintenance of this equipment.

BACKGROUND

The American Rescue Plan (ARP) Act of 2021 created new Coronavirus State and Local Fiscal Recovery Funds. The Act sets aside \$65.1 billion to be allocated to counties based on population and sent directly from the Department of Treasury. Gaston County has received it's full allocation of \$43,612,126. Pursuant to Section 13. 2 of Chapter 159 of the General Statutes of North Carolina, the Gaston County Grant Project Ordinance 2021- 264 for the Gaston County Coronavirus State and Local Fiscal Recovery Funds was adopted in Regular Session by the Gaston County Board of Commissioners on September 28, 2021. This Board Action, if approved, amends Section 2 of the Gaston County ARPA Grant Project Ordinance and accepts and appropriates funds for the following project:

- 1. Mobile Shower/Laundry Unit - 222,200:** The project will support an ongoing collaborative street outreach initiative. The initiative offers a mobile one-stop-shop for unhoused and low-income populations to access social services, healthcare, housing, behavioral health, and other supportive services. It is organized by a collaborative network of nonprofit, government, and faith-based organizations who specialize in providing these services to homeless and low-income populations.
