Gaston County proposes to provide a standard Level Two Economic Incentive Grant for Project KARMA. The company plans to invest approximately \$18,500,000 in an advanced manufacturing operation, which includes the purchase and installation of machinery & equipment. The company plans to create at least 200 new employment positions. The County Board of Commissioners intends, subject to public comment at the public hearing for which notice is hereby given, to approve a Level Two Grant to Project KARMA.

The Board of Commissioners believes this project will stimulate and stabilize the local economy, promote business, and result in the creation of new jobs in the County. The County's local grants are subject to the opening of a manufacturing facility in the Gaston County.

The Board of County Commissioners of the County of Gaston shall hold a public hearing on the County's proposed incentive agreement **at 6:00 o'clock p.m.**, in the Gaston County Courthouse, 325 Dr. Martin Luther King Way, Gastonia, North Carolina, **on Tuesday, December 12, 2017**, at which time any person may be heard regarding the project.
