



- WHEREAS, in January, 2017, Gaston County Sheriff Alan Cloninger was honored as the *North Carolina Special Olympics 2016 Torch Run Sheriff of the Year*; and,
- WHEREAS, the Torch Run Council selected Sheriff Cloninger for his leadership and outstanding commitment to raising funds to support Special Olympics North Carolina and "for being a true steward of the Flame of Hope"; and,
