- WHEREAS, the County of Gaston has been designated a Certified Local Government (CLG) by the North Carolina Department of Archives and History because of its progress in the historic preservation field; and,
- WHEREAS, the Gaston County Historic Preservation Commission applied for and received an historic preservation grant from the NC Office of Archives and History for the National Register City of Cherryville, Cherryville City Hall Masonry Repair Project in the amount of \$9,900; and,
- WHEREAS, the CLG received a matching donation in the amount of \$8,000 from the City of Cherryville; and,
- WHEREAS, this is a one-time project and will not require any county funding.
- NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners accepts and appropriates the grant from the North Carolina Department of Archives and the matching donation from the City of Cherryville, for the Cherryville City Hall Masonry Repair Project.
