All children who are suspected victims of child sexual abuse are entitled to a medical evaluation by a provider with specialized training. The Lighthouse--A Child Advocacy Center will contract with a qualified medical provider to perform exams. The CAC has been awarded a two-year grant (October 1, 2022-September 30, 2024) for medical evaluations.

The Gaston County Child Advocacy Center is fully equipped with a Medical Evaluation room for examinations for child victims. The Lighthouse will contract directly with a certified medical examiner for conducting sexual abuse exams for children. The CME will complete CME's in a child friendly manner that is compliant with NCA Accreditation Standards and CME guidelines. A CME's responsibilities include gathering information from the patient for the medical forensic history; an examination; coordinating treatment of injuries, documentation of biological and physical findings, and collection of evidence from the patient; documentation of findings; information, treatment, and referrals for
