operations thereat will generate significant ad valorem tax, sales tax and other revenues to the County and will qualify for a Level One Incentive Grant; the final value of the incentive will be based upon 50% of the assessed value as a result of Historical Tax exemption

status of the property; and,

WHEREAS. the County will prepare a detailed Economic Development Agreement (EDA), between

Tribridge Residential and the County, to provide a Level One Incentive Grant, so as to

induce the company to provide redevelopment and capital investment.

NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners approves a Level

One Incentive Grant, and further authorizes the Chairman, Vice-Chairman or the County Manager to execute any documents necessary to complete an Economic Development

Agreement for Tribridge Residential.
