BACKGROUND

On November 18, 2021, Governor Cooper signed into law the 2021-2022 North Carolina budget. The budget included a special appropriation of \$50,000 for the Gaston County Police to be used to purchase public safety equipment. All funding will be used to replace obsolete equipment.

- (1) Replace one obsolete Bomb Technician suit. Federal Standards require that two functioning suits must be in service to maintain certification.
- (2) Replace the Forensic Recovery of Evidence Device-DX workstation that secures, saves and analyzes data from hard drives and other media carriers. The current system is 8 years old and outdated.
