JUSTIFICATION FOR REQUEST:

NC Cooperative Extension has an established grant relationship with the Partnership for Children where they provide funding for Extension's Triple P intensive parenting education program for court-mandated and DSS referred clients. Additional funding for the program is provided by JCPC. The County Budget Department included initial funds in Extension's FY23 budget to cover salary and benefit costs until this new grant could be processed. This request accepts and appropriates a \$95,624 grant, adjusts the project line-items from what Budget initially entered, and returns appropriated fund balance back to the County due to the grant award.
