The Gaston County Board of Commissioners (BOC) met in Regular Session on September 26, 2023, at 6:00 pm in The Harley B. Gaston, Jr. Public Forum, Gaston County Courthouse.

Chairman Chad Brown presided with Commissioners Bob Hovis, Vice-Chairman; Cathy Cloninger, Allen R. Fraley and Ronnie Worley in attendance.

Commissioners Kim Johnson and Tom Keigher were not in attendance.

Others present included Dr. Kim S. Eagle, County Manager; William T. Stetzer, County Attorney; and Angela Stacks, Deputy Clerk to the Board.

Upon request of Chairman Brown, Commissioner Hovis led those assembled in the Invocation and the Bessemer City 12-U Girls Fast Pitch Softball All-Stars led in the Pledge of Allegiance.

Commissioner Hovis - BOC - Commendation - To Commend the Bessemer City 12-U Girls Fast Pitch Softball All-Stars Upon Winning the 2023 Dixie Youth Ponytails State Championship and the 2023 Dixie Youth 12-U World Series (Adopted under the Consent Agenda)

Commissioner Hovis invited the team and Coaches to the podium for the presentation of the Commendation; team members stated their names for the record (Avery Price, Blair Culberson, Bre Bates, Zoe Culberson, Ava Blanton, Lilly Stiffler, Hailey Morales, Addy Morehead, Victoria Payne, and Marissa Kiser (*Aiyona Gilliam and Oakleigh Herring were not in attendance*); Coaches Dustin Morehead, Ashley Price and Wes Culberson were also in attendance.

Coach Morehead accepted the Commendation and advised the team has created a lot of memories over the summer to last a lifetime and appreciate everyone's support. He noted that about 1,000 people watched the World Series live on YouTube and Facebook. He thanked the BOC for the Commendation.

His actions proved vital in these emergencies, and his dedication and care for others proudly reflect the highest ideals of the Gaston County Police Department and fellow law enforcement officers in North Carolina, the United States, and abroad. Mr. Johnson accepted the Certificate and advised after the choking incident he contacted LifeVac about its anti-choking device which uses negative pressure to pull out the choking device; he applied for a free LifeVac for Bessemer City High School which will be kept in the nurse's office; the school is one of the first schools in the County to have this and the program is available to the other schools also.

Chairman Brown thanked him for his dedication and for his assistance in both incidents.

Commissioner Hovis advised the BOC recognized the need for the services the SRO's (School Resource Officers) provide to the school campuses and is proud of the commitment the BOC has made to that program.

Chief Stephen Zill, County Police, thanked the BOC for recognizing Officer Johnson and the work of the County Police. He remarked that the Police have a great relationship with the Schools and hope that relationship continues.

Chairman Brown thanked Assistant Chief Anderson (Holder) and County Police staff for their dedicated service.

#### Brief Update from Gaston County Schools Interim Superintendent

Chairman Brown introduced the Schools Interim Superintendent for a brief update.

Dr. Stephen C. Laws, Schools Interim Superintendent, advised 137 parents attended Parents Advisory at Highland School of Technology last night; had a wonderful give-and-take session via sub-groups about what is good about the schools and what needs to be improved and will share that information with new Superintendent; Board of Education (BOE) is setting up interviews with candidates in the coming weeks; thanked the BOC for the SROs in all 56 schools.

Chairman Brown thanked Dr. Laws for his leadership.

Ms. Summey advised EDC is requesting BOC to approve a Level One Grant for Project Box and enter into an Economic Development Agreement (EDA); Project Box anticipates investing \$2.5M to upfit an existing facility (Gaston County Dye); expects to provide a substantial amount of new jobs with above-average wages; the Level One Grant will be a five-year grant totaling about \$45k; a company representative is present to answer any questions.

Chairman Brown called for citizen comment and for questions from the BOC; hearing none, the public hearing was closed and the Chairman called for a motion to approve

On motion introduced by Commissioner Hovis and seconded by Commissioner Fraley, the BOC unanimously approved **2023-292** as follows:

WHEREAS,	Project Box is considering a total investment of \$2,500,000 to design and upfit a manufacturing
	and distribution facility in Gaston County; and,

WHEREAS, North Carolina General Statute §158-7.1 authorizes a County to undertake an economic development project by providing grants for the location of industry; and,

WHEREAS, Gaston County developed an economic grant policy to provide global advanced manufacturing companies and distribution facilities with incentives to develop high quality industries in the

County; and,

WHEREAS, it is anticipated that the Company's capital investment in and at the Property and its operations thereat will generate significant ad valorem tax, sales tax and other revenues to the County and will gualify for a Level One Incentive Grant: and.

will qualify for a Level One incentive Grant; and,

Chairman Brown introduced Mrs. Sara Gilbert-Kay, EDC, for comments.

Mrs. Gilbert-Kay advised Project Precise is an existing company that is located within the County limits; Project Precise anticipates expanding production, adding to its existing building and adding two additional buildings on their property; anticipates their investment will add 31 new jobs with an average salary of \$58k over the next 12 months; propose to start their combined real estate and personal property investment the last of this year and to wrap it up by this time next year.

Chairman Brown called for citizen comment and for questions from the BOC; hearing none, declared the Public Hearing closed.

WHEREAS, Project Precise's investment is anticipated to add approximately 31 new jobs with an average salary of \$58,871 over the next twelve months; and,

WHEREAS, North Carolina General Statute §158-7.1 authorizes a County to undertake an economic development project by providing grants for the location of industry; and,

WHEREAS, Project Precise has requested an application to the NC Department of Commerce for a Building Reuse Grant to facilitate the project; and,

WHEREAS, Gaston County developed an economic grant policy to provide global advanced manufacturing companies and distribution facilities with incentives to develop high quality industries in the County: and.

WHEREAS, it is anticipated that the Company's capital investment in and at the Property and its operations thereat will generate significant ad valorem tax, sales tax and other revenues to the County and will qualify for a Level One Grant; and,

WHEREAS, the County will prepare a detailed Economic Development Agreement (EDA), between Project Precise and the County, to provide a Level One Incentive Grant, so as to induce the company to provide good job opportunities and capital investment which will enhance the County's ability to attract additional business and industry.

NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners approves a Level One Incentive Grant and an application for a Building Reuse Grant, and further authorizes the Chairman, Vice-Chairman or the County Manager to execute any documents necessary to complete an Economic Development Agreement, and an application to the NC Department of Commerce for a Building Reuse Grant for Project Precise.

Public Hearing – RE: Commissioner Hovis - Building & Development Services - Zoning Map Change: REZ-23-07-14-00153, Kimberly Hagans Bundy (Applicant); Property Parcel: 303966, Located on Freedom Mill Road, Gastonia, NC, Rezone from the (R-1) Single Family Limited Zoning District to the (R-2) Single Family Moderate Zoning District

Chairman Brown introduced Ms. Peyton Ratchford, Planner II - Building and Development Services, for comments.

Ms. Ratchford advised the application identified above is a general rezoning request from Kimberly Hagans Bundy (Applicant) for parcel 303966; the property is located on Freedom Mill Road (Gastonia); the Applicant is requesting to rezone the 1.95 acre parcel from the (R-1) Single Family Limited Zoning District to the (R-2) Single Family Moderate Zoning District; the property is located in the southwest corner of the County (south of Gastonia and Kings Mountain city limits).

She reviewed orthophoto, zoning and adjacent property owners maps and advised the parcel is currently vacant and surrounded by mostly residential properties with a few commercial properties located to the south (at the corner of Lewis Rd. and Freedom Mill Rd.); surrounding zoning districts include R-1, R-2 and C-3 south of the parcel; if approved, any uses in the R-2 will be permitted per standards and regulations adopted in the Unified Development Ordinance

(UDO); the site will be served by a private well/septic tank system; the site is along Freedom Mill Rd. which is an NCDOT maintained road; staff mailed notices to adjacent property owners about the public hearing on September 13 and posted a sign on the site per NCGS; staff received a few calls about the request that were general inquiries about what was going on.

The parcel is located in Area 5: Scenic Gaston/Southwest Gaston of the Comprehensive Land Use Plan (CLUP); key issues for area citizens include the preservation of open space, road improvements and better connectivity to other areas of the County and preservation of existing conditions while allowing low-to-moderate growth.

The future land use designation is Rural community (characterized as areas in largely Rural areas where there is a number of residential buildings on smaller lots built closer to the roadway; these areas have a rural look and feel).

The Technical Review Committee (TRC) reviewed the project and had no comments at this time and there are no planned transportation projects in the immediate vicinity.

The Planning Board heard the request at its September 11<sup>th</sup> meeting and recommended approval by a 6-0 vote; this concludes the presentation.

Chairman Brown called for comments from the Applicant and for citizen comment and for questions from the BOC; none was heard.

Chairman Brown declared the Public Hearing closed and recapped that the Planning Board unanimously recommended approval of the project.

Chairman Brown called for a motion to approve.

On motion introduced by Commissioner Fraley and seconded by Commissioner Hovis, the BOC unanimously approved Resolution **2023-294**, upon consideration of the map change application, public hearing comment and recommendation from the Planning Board and Planning staff finds:

1) The map change request is consistent with the County's approved Comprehensive Land Use Plan. It is consistent with the goals of the Comprehensive Land Use Plan as it will keep the parcel residential in nature and maintain the rural "feel" of the area, which is consistent with the parcel's rural community future land use designation.

The Commission considers this action to be reasonable and in the public interest, based on: Planning Board recommendation and compatibility with existing land uses in the immediate area. Therefore, the map change request for Property parcel: portion of 303966, is hereby approved, effective with the passage of this Resolution.

2) The County Manager is authorized to make necessary notifications in this matter to appropriate parties.

Chairman Brown asked the County Attorney to provide the Consistency Statement.

Hearing no objection from the Board, the County Attorney submitted a formal statement of consistency to the Clerk to be accepted into the record.

Public Hearing – RE: Commissioner Cloninger - Building & Development Services - Zoning Map Change: REZ-23-07-21-00154, Jeffery Lee Millwood (Applicant); Property Parcel: 166571, Located on 1044 Upper Spencer Mountain Rd., Stanley, NC, Rezone .97 Acres from the (R-1) Single Family Limited Zoning District to the (R-2) Single Family Moderate Zoning District

Chairman Brown introduced Mrs. Jamie Kanburoglu, Director of Planning and Zoning – Building and Development Services, for comments.

Mrs. Kanburoglu advised the application identified above is a general rezoning request from Jeffery Lee Millwood (Applicant) for parcel 166571 located on Upper Spencer Mountain Rd. (Stanley, NC); Applicant is requesting to rezone .97 acres from the (R-1) Single Family Limited Zoning District to the (R-2) Single Family Moderate Zoning District; the property is located in a residential area (in northern region of the County; just west of the Town of Stanley) and was within Stanley's ETJ until it was released to the County in 2021.

She reviewed an orthophoto map and advised the parcel is currently vacant; the location is heavily residential with mixed housing types throughout the area.

She noted for the record that a Code complaint was received about tractor-trailers being parked on the property; an investigation was conducted and a Notice of Violation was issued to the property owner with a 10/6/23 compliance date to have the tractor-trailers removed from the property; the property owner called the Land Use Officer today who verified they had been removed and the case is closed; property owner apologized and shared she did not know you cannot park a commercial vehicle on a lot less than one acre in size.

She reviewed the zoning map and advised the zoning districts surrounding the parcel includes mostly R-1 with some R-2 and R-3 zoning; the other parcels fall within Stanley's zoning jurisdiction; if approved, any uses in the R-2 would be permitted in accordance with standards and regulations adopted in the Unified Development Ordinance; the site will be served by a private well/septic system; Upper Spencer Mountain Rd. is a NCDOT maintained road.

She reviewed the adjacent property owners' map depicting those who were notified about the public hearing; advised staff received one call about the request concerning the current use of the lot and the call that initiated the Code case.

The parcel is located in Area 3: Riverfront Gaston/Northeast Gaston of the Comprehensive Land Use Plan (CLUP); key issues for area citizens include preservation of open space, road improvements and better connectivity to other areas in County and maintaining rural feel of area.

Because the property was previously within Stanley's ETJ, the property's default is best identified as Rural for future land use (Rural areas are characterized as having plenty of open space along with farmstead-style housing and opportunities for agribusiness; residential homes are located on large lots and set back from the roads they front upon).

Therefore, the map change request for Property parcel: 166571, is hereby approved, effective with the passage of this Resolution.

Ms. Littlejohn advised the FY25 Community Transportation Program grant is a state and federally funded program administered by the NCDOT Public Transportation Division; its goals are to achieve the definition of coordinated transportation services to support the general public transportation services in rural NC, provide a coordinated network enhanced access in rural areas to healthcare, shopping, education, employment, public service, recreation and to encourage the most efficient use of transportation funds used to provide passenger transportation.

As part of the administrative grant, the County will request a total amount of \$235,261 with a 15% local match (\$35,290) to help cover salaries of the Transportation Administrator and Billing Specialist, training and travel costs and lease of computer software (Routematch scheduling software) and a capital grant of \$2,059,000 with a 10% local match (\$205,900) to replace 15 vehicles that have met their useful life; this concludes the presentation.

(Clerk's Note: The Total Project Amount is \$2,294,261 with a Local Share of \$241,190.)

Chairman Brown called for citizen comment and for questions from the BOC; none was heard.

Chairman Brown declared the Public Hearing closed.

# 2023-318 Commissioner Worley - Finance - To Amend Gaston County ARPA Grant Project Ordinance 2021-264 to Approve and Appropriate Project Funding - Gaston College (\$3,200,000) and Tryon Elementary Waterline Extension Project (\$703,000) as follows:

**Section 1:** This ordinance is to establish a budget for a project to be funded by the Coronavirus State and Local Fiscal Recovery Funds of H.R. 1319 American Rescue Plan Act of 2021 (CSLRF). Gaston County has received the full \$43,612,126 allocation of CSLRF funds. These funds may be used for the following categories of expenditures, to the extent authorized by state law.

- Support public health expenditures, by funding COVID-19 mitigation efforts, medical expenses, behavioral healthcare, and certain public health and safety staff
- 2. Address negative economic impacts caused by the public health emergency, including economic harms to workers, households, small businesses, impacted industries, and the public sector
- 3. Replace lost public sector revenue, using this funding to provide government services to the extent of the reduction in revenue experienced due to the pandemic
- 4. Provide premium pay for essential workers, offering additional support to those who have borne and will bear the greatest health risks because of their service in critical infrastructure sectors
- Invest in water, sewer, and broadband infrastructure, making necessary investments to improve access to clean drinking water, support vital wastewater and stormwater infrastructure, and to expand access to broadband internet.
