

- WHEREAS, child abuse and neglect are a serious problem affecting every aspect of our community, and finding solutions requires input and action from everyone; and, WHEREAS, all children have the right to grow up in a safe, stable, and nurturing environment free from abuse and neglect; and, WHEREAS, children are the key to our community's future success, prosperity, and enriched quality of life and while children are our most valuable resource, they are also our most vulnerable; and, WHEREAS, most child abuse cases arise from situations and conditions that are preventable in an engaged, aware, and supportive community; and, WHEREAS, child abuse can have long-term psychological, emotional, and physical effects that have lasting consequences for its victims; and, WHEREAS, effective child abuse prevention strategies are created, nurtured, and implemented through partnerships with the Gaston County Department of Social Services. The Lighthouse Children's Advocacy Center, and local law enforcement; and, WHEREAS, The Lighthouse Children's Advocacy Center served 452 child victims of abuse or neglect in 2021; and, WHEREAS, one in ten children will be victims of sexual abuse before their 18th birthday; and, WHEREAS, over 90% of perpetrators of child sexual abuse are someone known by the child and/or family: and. WHEREAS, pinwheels are the national symbol for child abuse prevention. NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners proclaims the month of April 2022 as
