3. The service side arm, Glock, Model 45, Serial Number BRTV433 be permanently retired by the Gaston County Police Department and offered to Assistant Police Chief Jentsch for a purchase price of \$1.00.
4. The Chief of the Gaston County Police Department is directed to award Assistant Police Chief Jentsch with the service side arm and badge as specified and worn by him during his service to Gaston County, in accordance with the North Carolina General Statutes and the policy of the Board.

BE IT FURTHER RESOLVED that the Gaston County Board of Commissioners expresses their sincere gratitude for the dedicated service of Assistant Police Chief Stephen V. Jentsch and wishes him the best in his retirement.
