BACKGROUND

Cooperative Extension has been selected by the Partnership for Children of Lincoln and Gaston Counties (PFCLG) as the provider for the Triple P Parenting Program for the fiscal year July 1, 2025 through June 30, 2026 and has been allocated \$68,561 to conduct this parent education program.
