BUDGET ORDINANCE IMPACT

Increase Federal revenues by \$27,200 and appropriate \$27,200 into Special Programs account.

BACKGROUND

In June, 2019, DHHS received \$27,200 in additional Adoption Promotion Funds to be used exclusively to enhance the adoption program. The Adoption Promotion funds were deposited into the FY18-19 revenue account, which rolled to Fund Balance at year end closeout. These funds require appropriation to the FY2019-2020 Social Services Budget, therefore we are requesting to allocate from Fund Balance. These funds are carried forward each new fiscal year until funds are expensed.
