**JUSTIFICATION FOR REQUEST:**

The DHHS Social Services Adult and Aging Division received notification of approval for funds from the Older Americans Act through Centralina Council of Government in the amount of \$4,550. These funds will be used to provide training to promote good health to our senior population in Gaston County. These funds require appropriation to the FY2020-2021 Social Services Budget, so the funds can be used for the intended purpose. The funds are Federal funds and required a 10% County match of \$455.
