BACKGROUND

Per Resolution 2013-117, Gaston County accepted an NCDOT grant for \$875,000.00 to construct a network of trails, parking area, and drives at George Poston Park. Funds were appropriated in account # 40-6120-590-000 project #13282 -0001. The project will construct approximately .57 miles of paved walking trails, a 40 space parking lot, and associated drives. The project will open an existing, undeveloped portion of Poston Park and provide citizens access to the South Fork River portion of the park. Construction documents for the project were publicly advertised on December 3, 2015, and bids were received on January 6, 2016. Only two (2) bids were submitted so those were returned to the vendors unopened per NC procurement statutes. The project was re-advertised on January 8, 2016 and bids were opened on January 29, 2016 with the following results:
