Your preliminary payments for State Aid FY2025-26 are calculated based upon your 2024-25 recurring State Aid amount and adjustments required by eligibility criteria. Once the 2025-26 budget is verified by our Finance Group, we will finalize your library's total State Aid allocation and determine your monthly payment amounts for the remainder of the year. If there is a change to the State Aid allocation, this will have an impact on the payments for the remainder of the year.
