# **BACKGROUND**

Gaston County citizens and organizations often make donations to various programs within the Department of Health and Human Services - Social Services Division. During the Second Quarter of FY 2016-2017, donations totaled \$42,498 for the Shelter, Child Advocacy Center and Adult Services/Nutrition program. The Shelter of Gaston County received \$40,231 in donations to be used for rent deposits, utility deposits, prescribed medications, household items and other purchases to meet client and Shelter needs. Donations to Adult Services totaling \$1,297 will be used throughout Adult Services (as specified by the donors) to enrich various program activities for the elderly. And lastly, the Child Advocacy Center donations totaling \$970 will be used to enhance the services for abused children. The attached Budget Change Request appropriates the \$42,498 into the appropriate projects so the funds can used for the purposes intended.
