The Town of McAdenville has agreed to contract Gaston County for law enforcement services within its corporate limits and to confer to the County the necessary geographical and subject matter jurisdiction to carry out the intent of this agreement. The County will provide all needed equipment and personnel to fulfill the services outlined in the agreement. The expenses incurred will be reimbursed by the Town of McAdenville to Gaston County.
