BACKGROUND

The Comprehensive Opioid, Stimulant, and Substance Abuse Program (COSSAP) funding will support the Gaston County Police Department in collaboration with the DA's Office in planning, developing, and implementing a drug diversion and treatment program focused on the following objectives:

- 1) Bring together multiple county entities substance abuse treatment providers, law enforcement, courts, health care providers, and the faith-based community to collaborate in implementing a Law Enforcement Assisted Diversion Program (LEAD).
- Augment treatment and recovery services for individuals who are at high risk for overdose and recidivism and are participants in Recovery Court.
- 3) Incorporate transitional/recovery housing assistance and certified peer recovery support services into both the LEAD and the Recovery Court programs.
