

RESOLUTION TITLE: TO APPROVE A GASTON COUNTY LEVEL ONE INCENTIVE

GRANT PURSUANT TO N.C.GEN.STAT. §158-7.1 AND TO AUTHORIZE GASTON COUNTY TO ENTER INTO AN ECONOMIC DEVELOPMENT AGREEMENT (EDA) WITH

PROJECT BIG FISH

WHEREAS, Project Big Fish is considering a total investment of \$2,000,000 to expand their existing

operations in Gaston County, to include the purchase and installation of machinery & equipment; the investment will increase operational space to 30,000 square feet; and,

WHEREAS, the firm intends to create at least 10 new jobs within eighteen months of completing

their investment; and,

WHEREAS, North Carolina General Statute §158-7.1 authorizes a County to undertake an

economic development project by providing grants for the location of industry; and,

WHEREAS, Gaston County developed an economic grant policy to provide global advanced

manufacturing companies and distribution facilities with incentives to develop high

quality industries within the County; and,

WHEREAS, it is anticipated that the Company's capital investment in and at the Property and its

operations thereat will generate significant ad valorem tax, sales tax and other

revenues to the County and will qualify for a Level One Incentive Grant; and,

WHEREAS, the County will prepare a detailed Economic Development Agreement (EDA),

between Project Big Fish and the County, to provide a Level One Incentive Grant, so as to induce the company to provide good job opportunities and capital investment

which will enhance the County's ability to attract additional business and industry.

NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners approves a Level One Incentive Grant, as determined by County policy, and authorizes the

Chairman, Vice-Chairman or the County Manager to execute any documents necessary to complete an Economic Development Agreement for Project Big Fish.

BACKGROUND

Project Big Fish is considering a total investment of \$2,000,000 to upfit and occupy additional space. Big Fish will be increasing their operational capacity from 6,000 sq/ft to 30,000 sq/ft. This investment includes costs associated with upfit and purchase & installation of machinery and equipment. Project Big Fish anticipates 10 new additional jobs over eighteen months and is scheduled to be completed no later than the second quarter of 2024.
