#### NOVEMBER 28, 2023

The Gaston County Board of Commissioners (BOC) met in Rescheduled Regular Session at 6:41 pm on November 28, 2023, immediately following its Rescheduled Work Session, in The Harley B. Gaston, Jr. Public Forum, Gaston County Courthouse.

Chairman Chad Brown presided with Commissioners Bob Hovis, Vice-Chairman; Cathy Cloninger, Allen R. Fraley, Kim Johnson (via telephone) and Ronnie Worley in attendance.

Commissioner Tom Keigher was not in attendance.

Others present included Dr. Kim S. Eagle, County Manager; William T. Stetzer, County Attorney; and Donna S. Buff, Clerk to the Board.

Upon request of Chairman Brown, Commissioner Hovis led those assembled in the Invocation and Commissioner Worley led in the Pledge of Allegiance during the preceding Work Session.

Public Hearing - RE: Commissioner Fraley - Building & Development Services - Zoning Map Change: REZ-23-09-05-00162, Linda D. Pennington-Hardin (Applicant); Property Parcel: 310659, Located off Tot Dellinger Rd., Cherryville, NC, Rezone 2 Acres from the (R-1) Single Family Limited Zoning District to the (R-2) Single Family Moderate Zoning District

Chairman Brown announced the Public Hearings as advertised, outlined the Rules of Procedures for the hearings and called for a motion to enter into Public Hearing.

Commissioner Hovis introduced the motion and Commissioner Worley provided the second. Chairman Brown called for Commissioner Johnson's voice vote and called for the vote from the remaining members (via show of hands) and the BOC unanimously entered into Public Hearing.

Chairman Brown introduced Ms. Peyton Ratchford, Building and Development Services Planner II, for comments.

Ms. Ratchford advised the zoning request is from Linda D. Pennington-Hardin (Applicant) for parcel 310659 located off Tot Dellinger Rd., Cherryville, NC; Applicant is requesting to rezone the two (2) acres parcel from the (R-1) Single Family Limited Zoning District to the (R-2) Single Family Moderate Zoning District; the property is located in the northwest corner of County (north of Cherryville city limits).

She reviewed orthophoto and zoning maps and advised the parcel is currently vacant with a wooded area on the southeastern side of the property; surrounding zoning districts include R-1 and C-1; if the request is approved, any uses in the R-2 zoning district would be permitted per standards and regulations adopted in the Unified Development Ordinance (UDO).

The site will be served via a private well/septic system and is accessed off a privately maintained access easement off Tot Dellinger Rd., an NCDOT (NC Department of Transportation) maintained road.

She reviewed the adjacent property owners' map depicting those notified of the public hearing; advised public notices were mailed and the sign was posted on the site on November 8<sup>th</sup> per NCGS; she reviewed the property owners' information table depicting those who received a mailing notice.

She further advised that the subject parcel is located in Area 1: Rural Gaston/Northwest Gaston of the Comprehensive Land Use Plan (CLUP); key issues for area citizens include preservation of open space, road improvements, preservation of agriculture, and maintaining rural "feel" of community.

The future land use designation is Rural (characterized as having plenty of open space along with farmstead-style housing and opportunities for agribusiness. Residential homes are located on large lots and are set back on the roads they front upon).

The Gaston County Technical Review Committee (TRC) reviewed the project and had no comments at this time; in addition, there are no planned transportation projects in the vicinity.

The Planning Board heard the request at its November 6<sup>th</sup> meeting and recommended approval by a unanimous vote (6-0); this concludes the presentation.

Chairman Brown called for comments from the Applicant, for citizen comment and for questions from the BOC; hearing none, declared the Public Hearing closed.

Chairman Brown recapped the Planning Board unanimously recommended approval and called for a motion to approve.

Commissioner Fraley introduced the motion and Commissioner Hovis provided the second. Chairman Brown called for Commissioner Johnson's voice vote and called for the vote from the remaining members (via show of hands) and the BOC unanimously approved **2023-374**, upon consideration of the map change application, public hearing comment and recommendation from the Planning Board and Planning staff finds:

 The map change request is consistent with the County's approved Comprehensive Land Use Plan. It is consistent with the goals of the Comprehensive Land Use Plan as it will maintain the rural "feel" of the community by keeping plenty of open space along with farmstead style housing, as envisioned by the rural future land use designation.

The Commission considers this action to be reasonable and in the public interest, based on: Planning Board recommendation and compatibility with existing land uses in the immediate area. Therefore, the map change request for Property parcel: 310659, is hereby approved, effective with the passage of this Resolution.

2) The County Manager is authorized to make necessary notifications in this matter to appropriate parties.

Chairman Brown asked the County Attorney to provide the Consistency Statement.

The County Attorney responded that with the Board's permission, he will submit a written Consistency Statement to the Clerk.

Public Hearing - RE: Commissioner Cloninger - Building & Development Services - Zoning Map Change: REZ-23-09-05-00163, Derrick Kent Hunter (Applicant); Property Parcel: 167857, Located on 532 Upper Spencer Mountain Rd., Stanley, NC, Rezone 4.76 Acres from the (R-1) Single Family Limited Zoning District to the (R-3) Single Family General Zoning District

Chairman Brown introduced Mrs. Jamie Kanburoglu, Director of Planning and Zoning - Building and Development Services, for comments.

Mrs. Kanburoglu advised the zoning request from Mr. Derrick Kent Hunter (Applicant) is for parcel 167857 located on 532 Upper Spencer Mountain Rd., Stanley, NC; the request is to rezone 4.76 acres from the (R-1) Single Family Limited Zoning District to the (R-3) Single Family General Zoning District.

She reviewed an orthophoto map and advised the property is west of Stanley's municipal limits and north of Spencer Mountain; the parcel is heavily wooded and surrounded by residential uses (mixture of traditional/site-built homes and manufactured housing).

The lot is listed as vacant (per tax records); there is an existing single-wide manufactured home on the southeast portion of the lot (per survey completed 9/2023) that is being used as a storage unit; no one lives in it.

The Applicant went through the subdivision process for the parcel; staff approved the subdivision into two lots (3.48 acres for lot with the existing home; 1.51 acres for the second lot); it is staff's understanding the property owner subdivided the lot with intentions of giving it to his daughter; the subdivision was recorded on 10/31/2023 but has not been mapped on GIS yet; per the Unified Development Ordinance (UDO), only one primary dwelling unit is allowed on a lot that is less than 10 acres; a resident in area asked if the rezoning would approve multiple housing units on one lot and was advised by staff that only one residential principal dwelling would be allowed per each lot.

She reviewed the zoning map and advised the Applicant is requesting to rezone the parcel from R-1 to R-3; a large majority of the surrounding area is zoned R-1; there is an R-2 neighborhood east of the subject property with all manufactured homes.

She reviewed the adjacent property owners' map depicting those notified about the public hearing and advised that staff received two calls for general information about the request.

The lot will be serviced by a private well/septic system; access to the lot is off of an NCDOT (NC Department of Transportation) maintained road.

The GCLMPO (Gaston Cleveland Lincoln Metropolitan Planning Organization) showed there are no planned transportation improvement projects in the area and said the property owner would need to coordinate with DOT (Department of Transportation) for a driveway permit; staff did not receive any comments from the Technical Review Committee (TRC).

The property is in Area 3: Riverfront Gaston small area plan of the Comprehensive Land Use Plan (CLUP); key issues for citizens in area include preservation of open space, road improvements and better connectivity to other areas of the County and throughout the region, increased job opportunities and maintaining rural "feel" of the area.

The future land use designation is Rural Community. Rural communities are areas in largely Rural areas where there is a number of residential buildings on smaller lots built closer to the roadway. These areas have a neighborhood look and feel.

Per NCGS and the UDO, staff is asking BOC to receive the staff's report and presentation, Applicant's presentation and testimony, and any public comment. Per the UDO, the BOC can grant the request as presented, grant with a reduction of the area requested, grant to a more restrictive general zoning district, grant with a combination of subsections B & C (shown on slide) or deny the request.

The Planning Board did not recommend approval of the R-3 zoning district request; the motion was unanimously supported; however, the Planning Board did agree, and included in the record of their Minutes, that had the request been to rezone to the R-2 zoning district they would have supported the request.

Chairman Brown called for comments from the Applicant.

Mr. Derrick Kent Hunter, Applicant/property owner of parcel167857, advised he wanted to rezone the 4.7 acres to provide affordable housing for their daughter, future son-in-law and soon-to-be first child; had many questions and Mrs. Kanburoglu answered a lot of them via a short email:

("This is a common zoning district throughout the County; when they adopted the current Development Ordinance they purposely did not allow manufactured homes in the R-1 zoning district and then the R-1 zoning district was made to default zoning district for the County which created a lot of non-conforming situations for the existing manufactured homes. At the time, I think the goal was to reduce mobile home parks and manufactured housing in general and I don't think they accounted for the type of manufactured homes products being created today. There is a lot of new studies and blogs being written by the School of Government and even the new state statutes are clear about promoting the use of manufactured housing as it is meant to be an affordable housing type. Our staff plans to address this in rewrites of our Ordinance in the next few years".);

Mr. Hunter thanked BOC for hearing the request.

Chairman Brown called for citizen comment; hearing none, called for questions from the BOC.

Commissioner Worley noted that the Applicant stated he would be okay with a more restrictive rezoning of R-2; the BOC can do that if it will allow Applicant to do what he wants to do; sounds like it would, is that correct?

Mrs. Kanburoglu responded the R-2 zoning would allow the placement of a doublewide manufactured home; the R-3 is what allows for a single-wide manufactured home; per code, the zoning could be restricted to R-2, but his request is for the R-3 zoning district.

Chairman Brown asked if Applicant was sufficient with changing the rezoning to R-2.

The Applicant responded "yes, sir".

Chairman Brown asked if Commissioner Worley wanted to introduce a motion for the R-2 zoning district.

Commissioner Worley responded that is fine; want to work with Applicant within the code and the Ordinance; willing to make that motion if the R-2 allows the Applicant to provide affordable housing for his family member.

Chairman Brown declared the Public Hearing closed.

Chairman Brown recapped that the Planning Board unanimously recommended disapproval from the R-1 to the R-3; the BOC can accept the Planning Board's recommendation to disapprove; or the approval can go from a R-1 to a R-2.

Chairman Brown called for a motion to approve.

Commissioner Worley introduced the motion *to change the zoning district from R-1 to R-2* and Commissioner Hovis provided the second. Chairman Brown called for Commissioner Johnson's voice vote and called for the vote from the remaining members (via show of hands) and the BOC unanimously approved **2023-375**, upon consideration of the map change application, public hearing comment and recommendation from the Planning Board and Planning staff finds:

1) The map change request is consistent with the County's approved Comprehensive Land Use Plan. It is consistent with the goals of the Comprehensive Land Use Plan as it will keep the parcel residential in nature as envisioned by the rural community future land use designation. Rural community areas are largely in rural areas where there is a number of residential buildings on smaller lots, built closer to the roadway. The proposed use and district would also allow for the preservation of existing conditions in the area while allowing low to moderate growth in the Riverfront Gaston area of the Comprehensive Land Use Plan.

The Commission considers this action to be reasonable and in the public interest, based on: Planning Board recommendation and compatibility with existing land uses in the immediate area. Therefore, the map change request for Property parcel: 167857 is hereby approved, effective with the passage of this Resolution, to be rezoned to the more restrictive (R-2) Single Family Moderate Zoning District.

2) The County Manager is authorized to make necessary notifications in this matter to appropriate parties.

Chairman Brown asked the County Attorney to provide the Consistency Statement.

The County Attorney responded with the permission of the BOC that he would provide a written Statement of Consistency to the Clerk.

Public Hearing - RE: Commissioner Keigher - EDC - To Authorize a Gaston County Level One or Level Two Incentive Grant and Approve the Conveyance of Approximately 5.2 Acres of Land in the Gastonia Technology Park (GTP) Pursuant to N.C.Gen.Stat. 158-7.1; Authorize Gaston County to Enter Into an Economic Development Agreement (EDA) with Project Manitoba

Chairman Brown introduced Mr. Donny Hicks, Economic Development Director, for comments.

Mr. Hicks advised that staff is requesting the BOC to offer Project Manitoba a Level One or Level Two (Incentive) Grant and to convey 5.2 acres in the Gastonia Technology Park (GTP) for an expansion; the company plans to invest about \$7M and create 31 new jobs at an average salary of about \$56k/year; staff will go before City of Gastonia to ask them to match the same grant level.

He reviewed a drawing of the site to convey and advised it is a remnant piece that they knew had to be bought by someone for an expansion; the average value should be \$40k/acre; they made a cash offer of \$35k/acre; 1.2 acres of land is in the floodplain; within the floodplain is a wetland; so it is basically unusable; if you take out the unusable land and go back to the 4 acres that are net usable they are paying \$45.5k/acre for it; we think the cash offer is a fair offer for both parties; it gives the company what they need to expand and allows the County to sell it at a reasonable price.

Chairman Brown called for citizen comment and for questions from the BOC; hearing none, declared the Public Hearing closed.

Chairman Brown called for a motion to approve.

Commissioner Hovis introduced the motion and Commissioner Fraley provided the second. Chairman Brown called for Commissioner Johnson's voice vote and called for the vote from the remaining members (via show of hands) and the BOC unanimously approved **2023-376** as follows:

- WHEREAS, North Carolina General Statute 158-7.1 authorizes a county to undertake an economic development project by conveying property to a company in order to induce the company to locate or expand its operations within the county; and,
- WHEREAS, Gaston County and Project Manitoba have engaged in private negotiations for the conveyance of a 5.2 acre tract in the Gastonia Technology Park, to the end that Project Manitoba may expand their manufacturing facility on the tract, and they have reached tentative agreement on the terms for conveyance of the property, and for a Level One or Level Two Incentive Grant; and,
- WHEREAS, the Board of Commissioners of Gaston County has held a public hearing to consider whether to approve conveyance of the tract and the Level One or Level Two Incentive Grant to Project Manitoba; and,
- WHEREAS, Project Manitoba is considering a total investment of \$7,000,000 to design and expand and anticipates creating 31 additional job opportunities with an average annual salary of \$56,129; and,
- WHEREAS, North Carolina General Statute §158-7.1 authorizes a County to undertake an economic development project by providing grants for the location of industry; and,
- WHEREAS, Gaston County developed an economic grant policy to provide global advanced manufacturing companies and distribution facilities with incentives to develop high quality industries within the County; and,
- WHEREAS, it is anticipated that the Company's capital investment in and at the Property and its operations thereat will generate significant ad valorem tax, sales tax and other revenues to the County and will qualify for a Level One or Level Two Incentive Grant; and,
- WHEREAS, the County will prepare a detailed Economic Development Agreement (EDA), between Project Manitoba and the County, to provide a Level One or Level Two Incentive Grant, so as to induce the company to provide good job opportunities and capital investment which will enhance the County's ability to attract additional business and industry.

NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners:

 Authorizes the Chairman and Vice-Chairman of the Board of Commissioners to execute the necessary documents to convey to Project Manitoba the real property more particularly described below:

- 2. The conveyance of a 5.2 acre tract to Project Manitoba will stimulate the local economy, promote business, and result in the creation of a substantial number of jobs in Gaston County. The probable average annual wage at the facility to be constructed by Project Manitoba is \$56,129. The determination of the probable average annual wage at the facility is based upon materials provided to the County by Project Manitoba.
- 3. The fair market value of the property, subject to the covenants and conditions associated with the Gastonia Technology Park, is \$40,000.00 per acre. This determination of fair market value is based upon the sales prices of comparable tracts of land, as reported to the Board of Commissioners.
- 4. The Board of Commissioners has determined that the approximate value of the interest to be conveyed is Forty Thousand Dollars (\$40,000.00) per acre, for a total value of \$208,000.00, subject to survey. In consideration for the site PROJECT MANITOBA will pay \$182,000.00, in cash. This facility will generate property tax revenues over the next ten years in an amount at least to sufficiently return to the County the total fair market value of the property.
- 5. As further consideration for the conveyance of the property, Project Manitoba has agreed to expand the advanced manufacturing facility at a cost of at least \$7,000,000.
- 6. The Level One or Level Two Incentive Grant to Project Manitoba is approved and the Chairman, Vice-Chairman or the County Manager is authorized to execute any documents necessary to complete an Economic Development Agreement for Project Manitoba.

Ms. Summey advised staff is requesting a Level One (Incentive) Grant (five-year grant) for Project Server, a Danish company, that is looking to invest \$7M and to create 85 new jobs at an average annual wage of \$61k/year instead of investing \$5M and creating 50 new jobs as noted in Resolution; Project Server is a plastics pipe and pipe fitting manufacturer for the telecom industry;

they are looking at a vacant 50,000SF building in Belmont (former Marvalatex textile building); the state is supporting a Building Reuse Grant and a One NC Grant as well to upfit the building; the County is competing with three other states.

Chairman Brown called for citizen comment and for questions from the BOC; hearing none, declared the Public Hearing closed.

Chairman Brown called for a motion to approve.

Commissioner Worley introduced the motion and Commissioner Fraley provided the second. Chairman Brown called for Commissioner Johnson's voice vote and called for the vote from the remaining members (via show of hands) and the BOC unanimously approved **2023-377** as follows:

- WHEREAS, Project Server is considering a total investment of \$7,000,000 to establish a manufacturing operation in Gaston County, to include the purchase and installation of machinery & equipment; and,
- WHEREAS, the firm intends to create at least 85 new jobs over five years in Gaston County; and,
- WHEREAS, North Carolina General Statute §158-7.1 authorizes a County to undertake an economic development project by providing grants for the location of industry; and,
- WHEREAS, Gaston County developed an economic grant policy to provide global advanced manufacturing companies and distribution facilities with incentives to develop high quality industries within the County; and,
- WHEREAS, it is anticipated that the Company's capital investment in and at the Property and its operations thereat will generate significant ad valorem tax, sales tax and other revenues to the County and will qualify for a Level One Incentive Grant; and,

The County Attorney advised he will submit a formal letter of resignation to the Clerk on Thursday with an effective date of December 31<sup>st</sup>; his last day in the office will be December 15th; he will be sworn in as a Superior Court Judge on January 1<sup>st</sup> and would be honored if the BOC can attend his ceremonial swearing-in on January 5th at 2 pm.

Chairman Brown advised the County Attorney came to the County from the Attorney General's Office in Charlotte, NC and stepped into a job he thought would be difficult at best; he took it with stride and made it a passion to become the Attorney that he became for the County; he was appointed by the Legislature (General Assembly) to serve as a Superior Court Judge and will serve a full eight years; he noted that he did a great job for the County and the BOC wishes him the best.
