- WHEREAS, foster care is an irreplaceable resource for keeping children safe in temporary circumstances and providing stability, direction, and comfort to one of our community's most vulnerable populations; and,
- WHEREAS, children in foster care continue to face challenges even more pronounced by the opioid crisis and substance abuse disorder, which affect parents and guardians causing barriers and delays to reunification of families, and uncertainty and instability in normal activities such as school, sports, and church. Social workers, foster parents, and dedicated community members work tirelessly to assure they have safe, secure, and stable homes; and,
- WHEREAS, we honor those committed individuals who open their homes and hearts to children and provide a warm and nurturing environment, spaces to encourage and promote healing, and a secure place to live and grow; and,
- WHEREAS, our community, across all aspects of faith-based, non-profit, corporate businesses, volunteer and professional organizations continues to support individuals and families who have chosen to be foster parents; and,
- WHEREAS, dedicated child welfare professionals and community partners work to achieve permanency for children through reunification with birth parents, kinship care, adoption, or legal guardianship.
- NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners hereby proclaims the month of May 2023 as
