### **BACKGROUND**

The Gaston County Board of Elections has received up to \$80,000 in a supplemental reimbursement grant from federal and state funds from the CARES Act (P.L. 116-136) to provide an additional \$100.00 of supplemental pay to pollworkers and for additional expenditures incurred to prevent, prepare for and respond to expenditures related to Election Day voting. The Board Action accepts and appropriates these funds.
