Fire Advisory Board,

The Board of Directors of the Agriculture Center VFD is requesting the release of our Carry Over Funds (Reserve Fund). In 1998-1999, ACVFD purchased a Phoenix Rescue gasoline powered pump, one combination tool and a telescoping ram. With the purchase of our Rescue in late 2001, we purchased a full set of Phoenix Rescue Tools which consisted of an electric symo pump, 2 combination tools, two cutters, and both a small and a large telescoping ram. Much like other departments around the county, these tools have served us well but now through much use and training have become a maintenance problem. As you all know, Phoenix Rescue has since gone out of business and service and replacement parts are unavailable moving forward.

ACVFD has decided to replace these hydraulic tools with Hurst eDraulic tools. We intend to purchase 3 full sets (one for each Engine Co. and one for the Rescue) and an additional combination tool for the Rescue. Each set consists of a spreader, cutter & telescoping ram. Each tool comes with two batteries and a charger, and we will be purchasing an electric cord adapter for each set of tools.

We are attaching the quote for the tools, as well as a budget sheet. ACVFD is requesting all available carry over funds to purchase these tools. The small amount which is not covered by these funds will be supplemented by our general operating budget.
