General Description of Purchase

How Will Purchase Benefit the Department (Safety/ISO/Cost Savings, etc)

Our 31A area has rapidly been building out with new residential structures, some of which are quite large. This land purchase and subsequent new station development will allow us a quicker response time, a lowering of our ISO and give us a water point that we currently don't have. We will likely deploy some of our existing apparatus to this new location which will be a cost savings rather than having to purchase new and the time constraints on receiving new equipment.

We are currently debt-free and this land purchase will not strain our finances. We did not renew an approximate \$100,000 CD when it came due in 4th quarter of 2025 and we moved that money to the checking account to cover the purchase of this land and have seed money for the new building.

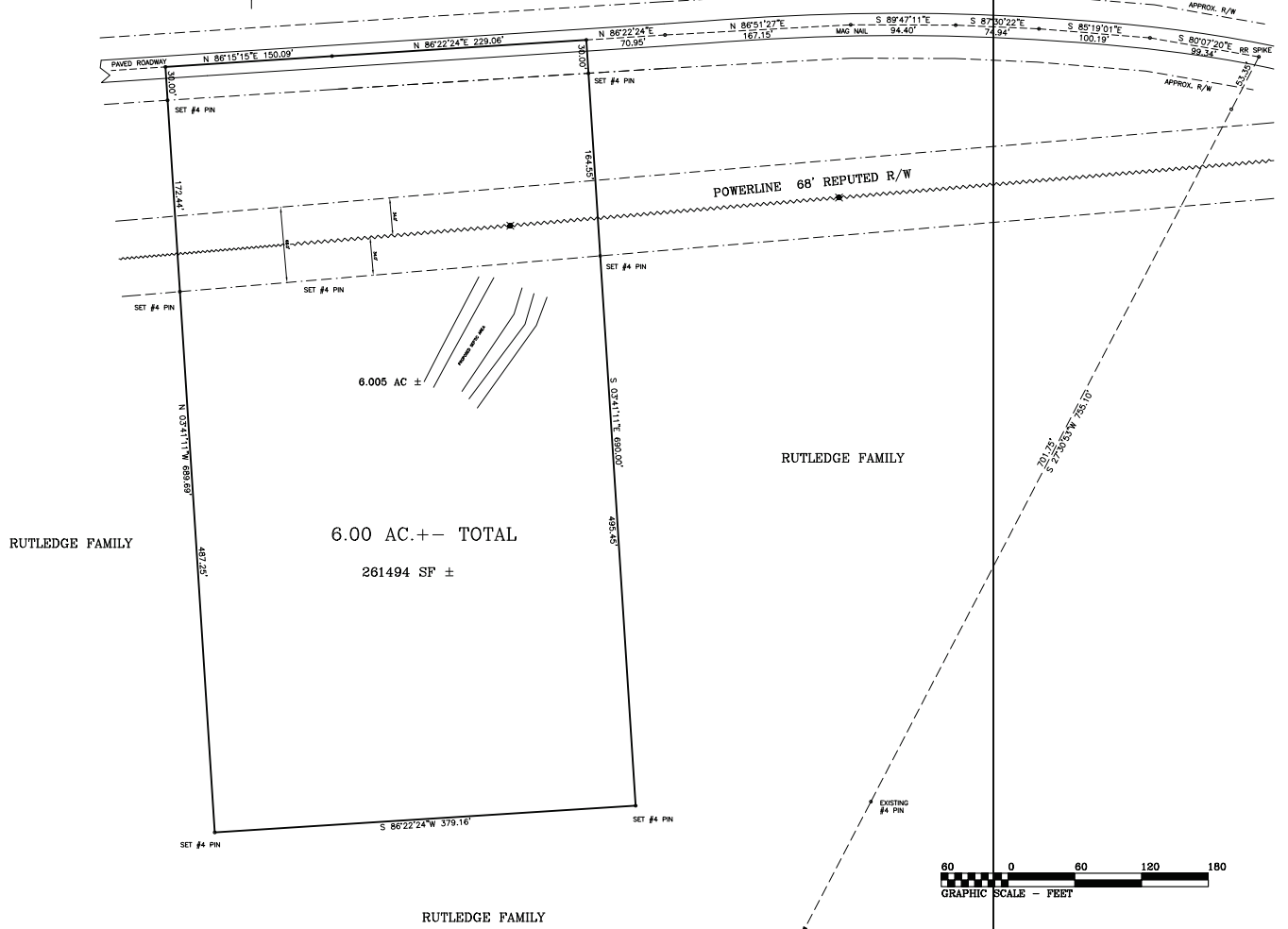
