These funds were deposited into the FY16-17 revenue account, but need to be appropriated in the FY17-18 expense account.

JUSTIFICATION FOR REQUEST:

In June, 2017, DHHS received \$127,800 in additional Adoption Promotion Funds to be used exclusively to enhance the adoption program. These funds were deposited into revenues for FY16-17, therefore, were rolled into the Fund Balance. The Adoption Promotion funds received and deposited require appropriation to the FY2017-2018 Social Services Budget. These funds are carried forward into the new fiscal year until funds are expensed.
