Appropriate FY2017 third quarter donations of \$38,994 into Special Programs accounts.

BACKGROUND

Gaston County citizens and organizations often make donations to various programs within the Department of Health and Human Services - Social Services Division. During the Third Quarter of FY 2016-2017, donations totaled \$38,994 for the Shelter, and Adult Services/Nutrition program. The Shelter of Gaston County received \$37,084 in donations to be used for rent deposits, utility deposits, prescribed medications, household items and other purchases to meet client and Shelter needs. Donations to Adult Services totaling \$975 will be used throughout Adult Services (as specified by the donors) to enrich various program activities for the elderly. And lastly, \$935 to the Adult Nutrition Program to enhance the Meals on Wheels services. The attached Budget Change Request appropriates the \$38,994 into the appropriate projects so the funds can used for the purposes intended.
