## **BACKGROUND**

During fiscal years 2010, 2011, 2012, 2014, and 2015, reimbursement funds were received from the United States Immigration and Customs (ICE) for overtime incurred while assisting federal authorities with undercover assignments. The Gaston County Police Department requests these funds be transferred to the Salaries-Overtime account to help cover overtime incurred in fiscal year 2015/2016.
