- WHEREAS, foster care is an exceptional resource for keeping children safe in temporary circumstances and providing stability, direction, and comfort to one of our community's most vulnerable populations; and,
- WHEREAS, there are numerous individuals, communities, and public and private organizations working to increase public awareness of the needs of children both in foster care and exiting foster care, and of the enduring and valuable contributions made by foster and kinship families; and,
- WHEREAS, we honor those committed individuals and families, who open their homes and hearts to children and provide a warm and nurturing environment, spaces to encourage and promote healing, and a secure place to live and grow; and,
- WHEREAS, our community, across all aspects of faith-based, non-profit, corporate businesses, and professional organizations volunteer their time, energy, and talents on behalf of children in foster care, and support individuals and families who have chosen to be foster parents; and,
- WHEREAS, dedicated child welfare professionals and community partners work to achieve permanency for children through reunification with birth parents, kinship care, adoption, or legal guardianship.
- NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners hereby proclaims the month of May 2025 as
