SEPTEMBER 26, 2017

The Gaston County Board of Commissioners (BOC) met in Regular Session on September 26, 2017 at 6:00 pm, in The Harley B. Gaston, Jr. Public Forum, Gaston County Courthouse.

Chairman Chad Brown presided with Commissioners Ronnie Worley, Vice-Chairman; Allen R. Fraley, Don Grant, Bob Hovis and Tracy L. Philbeck in attendance.

Commissioner Tom Keigher was not in attendance.

Others present included Earl Mathers, County Manager; Charles L. Moore, County Attorney; and Donna S. Buff, Clerk to the Board.

Upon request of Chairman Brown, Commissioner Philbeck led those assembled in the Invocation and Commissioner Hovis led in the Pledge of Allegiance.

<u>Public Hearings - City of Belmont – 1) Belmont Board of Adjustments; Belmont Planning</u> and Zoning Board ETJ

Chairman Brown announced the Public Hearings as advertised; explained procedures to be used; called for the motion to enter into Public Hearings.

On motion introduced by Commissioner Worley and seconded by Commissioner Hovis, the BOC unanimously entered into Public Hearings.

Chairman Brown reported that one position was available on the Belmont Board of Adjustments; application was received from Mr. Vernon Abernathy as recommended by the Belmont City Council, to serve as an extraterritorial jurisdiction representative. The Chairman called for any additional applications or comments.

Commissioner Philbeck explained his opposition to ETJs and reason for voting against ETJ appointments.

Hearing no further comments, Chairman Brown called for a motion to approve.

On motion introduced by Commissioner Hovis and seconded by Commissioner Worley, the BOC reappointed Mr. Vernon Abernathy to the *Belmont Board of Adjustments* to a term ending April 30, 2018.

The motion carried as follows: AYES: Commissioners Fraley, Brown, Hovis, Worley, Grant NAY: Commissioner Philbeck ABSENT: Commissioner Keigher

Chairman Brown called for a motion to continue the Public Hearing to the next Regular Meeting in order to allow enough time for the Belmont City Council to hold their public hearing for the Planning Board ETJ appointment.

On motion introduced by Chairman Brown and seconded by Commissioner Hovis, the public hearing was continued to the October 26th Regular Meeting.

Parks and Recreation Comprehensive Master Plan Presentation

Ms. Cathy Hart, Parks and Recreation Director stated the intent of the plan is to guide the County's decisions on parks for the next ten years. She introduced Mr. Derek Williams with Benesch for the presentation of the Parks & Recreation Master Plan, which is to be adopted as part of the Consent Agenda.

Mr. Derek Williams, Benesch, provided slides and presented as follows:

- Benesch has worked with staff and the Parks and Recreation Advisory Board for the past eight months in the development of the plan
- 5-step planning process largely driven by the public
- 10-year plan broken into 5-year increments, with the first five years being the highest priority; primary focus was County parks but also included a collaborative process with County municipalities in order to avoid duplication of services and facilities (over half of the County's population is living in a municipality that has a Parks and Recreation department)
- Step One performed an inventory of existing parks throughout the County and created a Gaston County parks, recreation and greenways map: 70 municipal parks with over 1,200 acres of land; County has 9 parks on almost 1,000 acres of land; County has joint-use opportunity with 10 school sites on 100 acres of land totaling 2,400 acres of park land; Crowders Mountain increases the total to over 5,000 acres of park land in the County. There is good distribution but there needed improvements including ADA issues. The service population (currently at 217,000) was studied and the 10-year plan was designed to adapt to projected population growth of approximately 20,000 people
- Step Two Public Input approximately 600 people provided input through an online survey (over 500 participants) and two public workshops. Key findings: existing parks are heavily used and valued; Dallas Park and George Poston Park are the most used facilities; there is a strong demand for expansion/improvement of facilities
- Step Three Development of Standards inventory information was overlayed with the public input; park standards were developed for mini-parks, neighborhood parks (municipality focus), community parks, district parks, and regional parks & greenways (County focus)
- Step Four Needs Assessment included both facilities and park acreage and needs for both County and municipalities. The assessment determined there is a strong demand for walking trails and greenways; a need to expand facilities that support family recreation; an interest in trending recreation facilities such as splash pads and community gardens; need for additional soccer fields and other athletic facilities
- Step Five Plan of Action -
 - Park Needs:
 - Develop several new mini parks and neighborhood parks (municipalities)
 - Existing community parks are currently meeting needs of County residents
 - Acquire land and develop new district park (100 acres) located in northeast area of County (Stanley area) within next ten years

<u>Recreation Facility Needs</u> – there are needs for every type of recreation facility with emphasis on multi-use fields, playgrounds, picnic areas and splash pads (County and municipalities).

Special Use Facilities

- Recommend the construction of several spray grounds (one is planned for Dallas park) and include splash pads in other parks in the future
- Expand greenway trails strong demand for walking, jogging and biking

Park needs (10-year plan)

- Renovate existing park areas
- Improvements to Senior Center
- Encourage development of additional infrastructure at Crowders Mountain State Park
- Expand building and grounds staff to maintain expanding park system

<u>Park Development Priorities and Order of Magnitude Costs</u> – recommended capital improvement budget (\$18M):

- Renovation of existing parks (capital improvements/land acquisition) \$8.5M; development of additional spray grounds; \$275k improvements to Senior Center; ADA improvements
- Acquisition of land and development of new northeastern district park \$2.75M
- Construction of 3-5 miles of new greenways \$5M (improvements/expansion).

Commissioner Fraley requested an update on the renovations that were approved from the CaroMont lease proceeds.

Ms. Hart stated that improvements were made to the Dallas Park to mitigate the gas line issue; received an update that the gas company is verbally committed to the plan; should be bringing plans to the BOC in November. The renovations include a splashpad, dog park with water access, multi-purpose soccer/lacrosse/rugby field, fitness pavilion, walking trails, and a shade structure over the existing playground.

Mr. Josh Taylor, Chairman of the Parks and Recreation Advisory Board, provided the Board with an update on the new ADA trail section of the park and the future plans for additional trails.

Chairman Brown suggested that the CaroMont lease proceeds be used as matching funds for the PARTF (Parks and Recreation Trust Fund) grant.

2017-232 Commissioner Brown - County Attorney - To Provide an Advisory Opinion to the North Carolina Department of Transportation (NCDOT) Recommending an Abandonment of the Easternmost 315 Feet of Bay Shore Drive

Chairman Brown called for a motion for the purposes of discussion. Commissioner Philbeck introduced the motion and Commissioner Worley provided the second.

Chairman Brown introduced Mr. Gary Spangler, NCDOT District Engineer for comments.

Mr. Spangler explained that when the NCDOT receives a petition to abandon, the first step is to see if there are any other property owners involved. Once it is determined that the petitioners are the sole property owners affected by the request, it is sent to the County Commission with a request for support or denial. The Commission's recommendation is then sent to the Board of Transportation for consideration. He concluded that the NCDOT is only considering abandonment of the maintenance of the road and not the right of way (ROW) of the road.

Commissioner Hovis requested confirmation that the abandonment of the maintenance is only for the portion outlined in the petitioner's request.

Mr. Spangler confirmed the request is to abandon the last section (few hundred feet) of the road. A broader request would require consent from all of the property owners. He also confirmed that the requested turnaround (for school buses, emergency vehicles and other traffic) had been constructed and was actually larger than the previous turnaround.

Chairman Brown called for the vote and the BOC unanimously approved **2017-232** To Provide an Advisory Opinion to the North Carolina Department of Transportation (NCDOT) Recommending an Abandonment of the Easternmost 315 Feet of Bay Shore Drive (as outlined by the petition).

- WHEREAS, a certain state-maintained road known as Bay Shore Drive exists in Gaston County; and,
- WHEREAS, a property owner wishes to ultimately to close approximately three hundred and fifteen (315) feet of the easternmost portion of said right of way; and,
- WHEREAS, NCDOT requests that the County Commissioners make a recommendation to the NCDOT concerning abandonment of a state-maintained right-of-way; and,
- WHEREAS, the NCDOT takes such recommendation into account when the NCDOT issues a final decision concerning the request to abandon a right-of-way; and,
- WHEREAS, if the NCDOT subsequently abandons the subject right-of-way, the Gaston County Board of Commissioners, upon application, can consider the merits of the subject right-of-way being

closed. Such consideration cannot be undertaken unless the NCDOT abandons the right-of-way from state control.

NOW, THEREFORE, BE IT RESOLVED, that the Gaston County Board of Commissioners recommends to the North Carolina Department of Transportation that the subject property, being approximately three hundred and fifteen (315) feet of the eastern most portion of Bay Shore Drive, as depicted on said map, be abandoned.

2017-233 Commissioner Brown - County Attorney - To Amend a Section of Chapter 7 of the Gaston County Code of Ordinances to Prohibit Littering and Vehicles Improperly Securing and Transporting Waste (First Reading)

On motion introduced by Commissioner Grant and seconded by Commissioner Fraley, the BOC unanimously approved the *FIRST READING* of the amendment to Chapter 7 of the Gaston County Code of Ordinances as follows:

- WHEREAS, Gaston County has a significant governmental interest in protecting the health, safety, aesthetic appearance and welfare of its employees, customers, and general public; and,
- WHEREAS, the County may, pursuant to G.S. 153A-136, adopt an ordinance to regulate solid waste and prohibit littering; and,
- WHEREAS, the County wishes to prohibit littering by way of a County Ordinance, and prohibit vehicles from improperly securing and transporting waste.
- NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners hereby adds Section 7-3(q) and Section 7-3(r) to Section 7-3 entitled "Storage and disposal":

Chapter 7: Garbage and Trash Sec. 7-3. Storage and disposal

(q) No person shall transport solid waste, garbage or refuse at any time, including yard waste, demolition waste, construction waste, or landscape waste, in any container or vehicle unless the waste is covered by being in an enclosed vehicle or container or otherwise adequately secured.

(r) Throwing, littering, scattering, spilling, placing, dumping, depositing or causing or allowing the same of any solid waste, garbage or refuse upon any property, which is inconsistent with solid waste management or other disposal practices, is prohibited.

This Ordinance amendment shall be effective immediately upon its adoption.

Chairman Brown called for a motion for the purposes of discussion. Commissioner Hovis introduced the motion and Commissioner Worley provided the second.

In response to Commissioner Philbeck, the County Manager stated that an analysis had been conducted initially on the cost/benefit of transporting inmates due to overcrowding at the jail. A more definitive formula is being developed to analyze outsourcing of inmates and maintaining the US Marshal Federal Inmate Housing Program.

Chief Deputy Williams stated that it costs \$40/day/inmate to ship to other counties and the County receives \$73/day/inmate for federal inmates. He also explained that transporting was weighed against the potential cost of losing the U.S. Marshal Housing Program. He also noted that the two Board Actions were for previous transports and no inmates are currently housed outside of the County.

Commissioner Philbeck requested that more information be provided to the Board going forward and Chairman Brown reiterated that future Agenda items should include exact figures.

Commissioner Hovis stated that the two board items highlight the unusual costs associated with the current inmate housing/overcrowding situation. He noted past discussions regarding the infill project at the jail; pointed out rising inmate population over the years; noted there is nothing that indicates a reversion to 2007 trends. He also added that the jail has been operating under mandatory overtime, which is costing the County far beyond these two items.

Chief Deputy Williams stated that 16 inmates were transported to Cherokee County and 15 to Yadkin. He explained that inmates are brought back once numbers drop or if they make bond or have a court date. He also stated that he would be bringing statistics to the Board regarding the impact of the opioid epidemic on the jail population.

Chairman Brown called for the vote and the BOC unanimously approved **2017-235** Appropriation of Additional Funds to House Inmates at the Yadkin County Detention Center (\$15,480.00) per Budget Change Request:

2017-236 Commissioner Brown - County Attorney - To Approve the Transfer of Title of a Portion of the Orthopedic Hospital Property to Partners Behavioral Health

Chairman Brown called for a motion for the purposes of discussion. Commissioner Philbeck introduced the motion and Commissioner Fraley provided the second.

Commissioner Grant stated he was asked to attend a meeting earlier in day with County staff and a couple other people regarding a proposed plan for the property. He stated that he did not have a clear understanding of the issue and was displeased that he found out about it so late. He suggested tabling the item until everyone had a chance to look at the proposal.

Chairman Brown stated that the issue came to the Board more than a year ago and the State has since relinquished the property to the County with the help of Representative John A. Torbett.

Commissioner Grant inquired how many Gaston residents are currently employed with Partners.

The County Manager stated that 240 people are employed at the Gastonia location; not certain how many are Gaston residents; jobs are well above average in terms of the compensation. He added that the State transferred the property to the County with the understanding that we would in turn provide a permanent home for Partners so that they could continue to deliver these vital and mandatory services to our community. Partners has been on the campus for several years and Gaston County has facilities onsite as well. There are claw-back provisions that would require the property to revert back to the County should Partners cease operations. There was never any intention of charging them any money for occupying the property.

Chairman Brown stated he would like to move forward with the vote. He called on Ms. Debbie Clary, Gaston County Governmental Relations Consultant, for comments.

Ms. Clary stated the conversations surrounding this property began in 2016. Partners has been an integral part of health care in Gaston County and it was important to shore up that relationship. The "nurses dormitory" property is very unsafe and attracts vagrants. The goal is to be able to prepare that property for additional jobs and to that end, she worked with the State property division and Representative Torbett to transfer ownership of the property to the County for this explicit purpose. Ms. Clary read an excerpt from Rep. Torbett's letter: "*The continued effort and successes of providing those health related services offered by Partners and having Partners located on this property that provides tremendous growth potential was the driving force and full intent behind the transfer taking place. I feel a change to the scope of the original "Ask" would not be prudent, and I know that Partners will continue to play a vital role in support of the health needs of our citizens well into the future."*

Ms. Clary concluded that the original goal for Gaston County is to keep and expand jobs in Gaston County. Partners has just added 7-8 new positions and former Commissioner and House of Representative Pearl Burris-Floyd was hired as the Chief Governmental Affairs Officer for Partners.

Chairman Brown clarified that the earlier meeting and the information presented was driven by an outside entity and not by Partners or County staff. He also clarified that he had not heard the proposal before today.

Commissioner Worley called the question.

Chairman Brown called for the vote and the BOC approved **2017-236** by a vote of 5-1.
