BACKGROUND

The Transitional Housing Program will provide subsidized rent and utilities and make available direct support services such as counseling, case management for housing, job readiness skills, employment, education, transportation assistance, public benefits, and referral to outside services for participants beginning at in-take and continuing through after-care with follow-up contact for six months after exiting the program. Phoenix Counseling Sexual Assault and Rape Crisis Center will be the implementing agency.

JUSTIFICATION FOR REQUEST:										

Gaston County will collaborate with multiple County departments (Gaston County Sheriff's Office, The Cathy Mabry Cloninger Domestic Violence Center, Health & Human Services, Hope United Survivors Network, Gaston County Work Force Development), Phoenix Counseling Sexual Assault & Rape Crisis Center, Gaston College, and three housing partners to implement a Transitional Housing Program that will provide stable and secure housing to victims of domestic violence and/or sexual assault. The program's goal is to assist approximately 30 victims with transitional housing and wrap-around services that will empower survivors to rebuild their lives and to achieve long-term safety and stability. Expected outcomes are improved safety, well-being and self-sufficiency and increased permanent connections. The service area will be all of Gaston County (pop. 222,846) with priority consideration given to victims residing in designated rural areas.
