RESOLUTION TITLE: AMENDMENT TO THE GASTON COUNTY TRAFFIC CONTROL ORDINANCE (FIRST READING)

WHEREAS, Gaston County currently has a traffic ordinance located in Chapter 16 of the Gaston County Code of Ordinances; and,

WHEREAS, said ordinance was updated in 2009 and 2015 concerning parking regulations at the County Courthouse; and,

WHEREAS, clarifications to the ordinance are necessary.

NOW, THEREFORE, BE IT RESOLVED, by the Gaston County Board of Commissioners that Chapter 16 of the Gaston County Code of Ordinance be amended as follows:

Sec. 16-8. Penalties.

(b) Towing: Violation of this article may result in the towing <u>or immobilization</u> of the motor vehicle from the parking lot and storage of the vehicle at the owner's expense.

Sec. 16-9. Towing and immobilization.

(d) When a motor vehicle is removed or towed away under this section it may be released to the owner or operator of such motor vehicle upon payment by the owner or operator of all reasonable costs incurred in the towing of such vehicle including, but not limited to, actual towing cost and storage for the vehicle in addition to satisfying all outstanding penalties or citations. The payment of reasonable costs including towing shall be in addition to any other penalties set forth in this article.
