BACKGROUND

The 21st Century Learning Center in Gaston County supports students at Woodhill Elementary School, a Title 1 school. This federal grant funding provides 150 slots in an after-school program for K-5 students and is given in three installments for a total of \$400,000 per year. Woodhill must meet attendance goals to receive the 3rd (\$128,000) installment.
