Increase Fund Balance by \$20,000 and increase Equipment/Furn. Account by \$20,000.

BACKGROUND

Additional appropriation of fund balance in the amount of \$20,000 for the procurement of Point Blank Paraclete mid-cut helmets for Gaston County Police Officers. The helmet offers IIIA threat level protection and includes a ratcheting suspension system. The department will also be replacing incandescent streamlights with LED stinger streamlights. The additional appropriation of funds is per Resolution 2016-218 Adopted July 28, 2016.
