the North Carolina Department of Environmental Quality has offered American Rescue Plan (ARP) funding in the amount of \$4,225,000.00 to perform work detailed in the submitted application; and,

WHEREAS.

Gaston County intends to perform said project in accordance with the agreed scope of work.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Gaston County:

- 1) That Gaston County does hereby accept the American Rescue Plan Grant offer of \$4,225,000.00.

- 3) That Ray Maxwell, Infrastructure & Asset Manager, and successors so titled, is hereby authorized and directed to furnish such information as the appropriate State agency may request in connection with this project; to make the assurances as contained above; and to execute such other documents as may be required by the Division of Water Infrastructure.

BUDGET IMPACT

Increase revenues and expense by \$6,082,000 in both the Community Investment and General Government CIP funds.

BUDGET ORDINANCE IMPACT

Minimal change to the Budget Ordinance.

BACKGROUND

The NC Division of Water Infrastructure will award a total of \$1.69 billion in American Rescue Plan Act funding from the State Fiscal Recovery Fund for water, wastewater, and stormwater projects. Gaston County was appropriated \$4,225,000 from the Drinking Water and Wastewater Reserve in the Other Projects Category for the High Shoals, Hardin, Dallas - Wastewater Project (Project #SRP-W-ARP-0074). This project consists of two new sewer pump stations and the associated force mains to connect those pump stations to the City of Gastonia's sewer outfall. High Shoals currently owns a sewer collection system that serves part of the area inside the city limits and discharges wastewater to an outfall owned by the City of Gastonia. One of the pump stations will be located on a vacant tract in the northwest quadrant of the Hardin Rd/US321 interchange that is targeted for economic development. The other pump station will be located just off of the Dallas High Shoals Hwy / Miles Road intersection and will serve a large tract inside the High Shoals city limits currently planned for residential development (approximately 600 units). High Shoals currently has less than 300 sewer customers and the new customers will improve their ability to provide a high quality and responsible level of service to their residents. In total approximately 15,500 feet of 10" force main will be constructed to connect the two pump stations to an existing sewer outfall owned by the City of Gastonia.
