Due to not having a State budget for the first 3 months of the State fiscal year, the State was not able to upload the capped allocations for DSS reporting. Therefore, our agency was reimbursed the full amount allocated to SSBG. Now, the State is drafting the overpayment of \$482,367.82 from the county. Since the State's first payment month for FY24 is our June service month, the first reimbursement was accrued back to FY22-23. We are requesting to appropriate \$114,956.12 from Fund Balance into the FY24 budget so we can post the State draft for the overpayment.
